आपकी संस्था को महर्षि दयानन्द विश्वविद्यालय, रोहतक एवं कुरुक्षेत्र विश्वविद्यालय, कुरुक्षेत्र द्वारा 2009-10 में दी गई अस्थाई सम्बद्धता के आधार पर शैक्षिक सत्र 2018-19 के लिये इस बोर्ड द्वारा निम्न शर्तों पर अस्थाई सम्बद्धता प्रदान की जाती है :-

1. संस्था बोर्ड/ शिक्षा विभाग, हरियाणा द्वारा निर्धारित किए गए पाठ्यक्रम एवं समय-समय पर परीक्षाओं से सम्बन्धित जारी दिशा-निर्देशों की दृढ़ता से पालना करेगी।
2. बोर्ड/शिक्षा विभाग, हरियाणा की पूर्व स्वीकृति बिना संस्था किसी भी स्तर पर पाठ्ययोजना में किसी भी प्रकार का संशोधन/परिवर्तन नहीं करेगी।
3. संस्था परीक्षाओं के संचालन के लिए अपनी संस्था का भवन/फर्नीचर एवं अपने स्टाफ की सेवाएं बोर्ड को उपलब्ध करवायेगी। बोर्ड द्वारा भवन एवं फर्नीचर का किराया आदि नहीं दिया जायेगा।
4. संस्था बोर्ड द्वारा संचालित परीक्षाओं को सुचारु रूप से चलाने के लिए बोर्ड को पूर्ण सहयोग देगी जिससे अनुचित साधन प्रयोग मामलों, इम्पर्सोनेशन व अन्य अनियमितताओं पर पूर्ण नियन्त्रण किया जा सके।
5. बोर्ड के निर्देशानुसार शिक्षकों/छात्रों का रिकार्ड तथ्यों की जांच हेतु मांगने पर उपलब्ध करवाना होगा।
6. संस्था का निरीक्षण बोर्ड द्वारा गठित कमेटी /नियुक्त अधिकारी द्वारा किया जा सकता है।
7. संस्था द्वारा एन.सी.टी.ई. के निर्देशानुसार गवर्निंग बॉडी का गठन किया जाना अनिवार्य है।
8. स्वीकृत सीटों से अधिक व शिक्षा विभाग द्वारा संचालित काउंसिलिंग के अतिरिक्त छात्रों को प्रवेश नहीं दिया जायेगा।
9. यदि संस्था एन.सी.टी.ई. की स्वीकृति से अपने भवन को मूल स्थान से शिफ्ट करती है तो इसकी सूचना बोर्ड कार्यालय, एस.सी.ई.आर.टी., हरियाणा, मौलिक शिक्षा विभाग, हरियाणा को एन.सी.टी.ई. के स्वीकृति पत्र की प्रमाणित प्रति सहित, स्वीकृति मिलने के 15 दिनों के भीतर प्रेषित करेगी।
10. अस्थाई सम्बद्धता जारी रखने के लिये प्रत्येक शैक्षिक सत्र में 50000/- रुपये निरन्तरता सम्बद्धता शुल्क सचिव, हरियाणा विद्यालय शिक्षा बोर्ड, भिवानी को भेजा जाना आवश्यक है।

WHEREAS, in exercise of the powers conferred by subsection (2) of Section 12 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in pursuance of the National Council for Teacher Education (Regulation Norms and Procedure) Regulations, 2014, the National Council for Teacher Education has notified the Regulations, 2014 (NCTE/HR/REG/11/1944/2).

AND WHEREAS, the institution i.e. Dr. B.R. Ambedkar College of Education, Village Khari Markanda, Distt. Kurukshetra, Haryana has been recognized for M.Ed course by SRC vide order No. F.NRC/NCTE/F-7/HR/505/2007/33308 dated 30th Nov 2007.

AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for one basic unit in M.Ed., which requires additional facilities.

AND WHEREAS, it has been decided to permit the institution to take one basic unit of its students subject to the institution fulfilling following conditions:

- (i) The institution shall create additional facilities that include (a) additional hostel, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions on 29 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court/tribunal/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to attach a copy of the court/tribunal documents referred above. In case the institution's request for entry of premises is pending such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 in the form of a copy of the order/NOI issued by the State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the writ Petition/Case decided by the Northern Regional Committee in respect of Section 17-complaint case etc.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND WHEREAS**, the institution **Dr. B.R. Ambedkar College of Education, Village Kheri-Markanda, Distt. Kurukshetra, Haryana** has by affidavit consented to come under New Regulations and sought for four basic units in B.Ed., which requires additional facilities.

3. **AND WHEREAS**, it has been decided to permit the institution to have four basic units of 50 students subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

4. **Now therefore**, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to **Dr. B.R. Ambedkar College of Education, Village Kheri-Markanda, Distt. Kurukshetra, Haryana** for conducting B.Ed. programme of two years duration with an annual intake of 200 (two hundred only) students from the academic session 2015-2016 subject to fulfilment of the conditions mentioned herein before 31.10.2015.

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 **Dr. B.R. Ambedkar College of Education, Vill- Kheri Markanda, Post- Kurukshetra, Tehsil- Kheri Markanda, District- Kurukshetra- 136118, Haryana**, has submitted an application (Code No **APN-06412**) to the **Northern Regional Committee of NCTE** for grant of recognition/permission for starting **D.ED** Course of **two year** duration with an annual intake of **50 (Fifty only)** students on **20th Feb 2008**.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Elementary** teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to **Dr. B.R. Ambedkar College of Education, Vill- Kheri Markanda, Post- Kurukshetra, Tehsil- Kheri Markanda, District- Kurukshetra- 136118, Haryana, Haryana** for conducting **D.ED**. Course of **Elementary** level of **two year** duration with an annual intake of **50 (Fifty only)** students from the academic session **2008-2009** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:-

- i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the **Northern Regional Committee**.
- ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
