# As fire is enveloped by smoke, as a mirror by dust, as an embryo by the womb, so this (wisdom) is enveloped by desire

Desires fall under three categories according to the quality of the attachment – inert, or active, or noble and divine

 'Fire enveloped by smoke' - signifies wisdom enveloped by sattva. A passing breeze or slight effort is sufficient to remove the smoke. So too, a little effort is sufficient to remove the sattvika desires that cloud our wisdom.

 'A mirror covered by dust' – indicates wisdom covered by rajas. Just as an effort of wiping is required to remove the dust, so too one needs to put in a little effort to remove the rajasika desires.

3. 'The embryo covered by the womb' – indicates wisdom covered by tamas. Effort alone is incapable of freeing the baby from the womb. It takes time and patience to be free from tamasika desires.

# Dharamkshetra Kurukshetra

According to the Puranas, Kurukshetra is a region named after King Kuru, the ancestor of Kauravas and Pandavas, as depicted in epic Mahabharata. The importance of the place is attributed to the fact that the Kurukshetra War of the Mahabharata was fought on this land and the Bhagavad Gita was preached here during the war when Lord Krishna found Arjuna in a terrible dilemma.

At the time between Dwapara and Treta Yugas, Parasurama, the son of Jamadagni rishi, annihilated the entire tribe of Kshatriyas twenty-one times in an act of revenge (He did this to avenge his father's death at the hands of a Kshatriya). The blood from the slaughter formed five lakes, and hence that region came to be known as Samanthapanchaka, aka, the five lakes of blood.

His forefathers, satisfied by Parasurama's offering of the blood in the lakes, requested him to cease the killing of Kshatriyas. The manes also expressed their desire to offer Parasurama a boon, Parasurama asked that he be absolved of his sins from the slaughter of Kshatriyas, and that the region of the lakes become a holy one. The forefathers acceded to the rishi's requests. This region of Samanthapanchaka later came to be known as Kurukshetra (Brahma Sarovar).

# How to Apply

The admission form can be obtained from the Institute Administrative Office on payment Rs. 600/- those who want the admission form by post, should send DD of Rs. 750/- in favour of Principal, Dr. B. R. Ambedkar College of Education Kurukshetra Haryana & Mahabir College of Education for women Kurukshetra Haryana. The admission form can also be downloaded from the website of Ambedkar Mahabir Group of Institutions (www.amikurukshetra.org). However, such candidate will have to enclose a DD of Rs. 600/- with the downloaded Admission form.

#### Important Instructions for filling up the Admission form

The Admission Form for admission to any course, duly completed in all respects, must be accompanied with the following documents (please see eligibility at page no.):

- (a) A recent passport size photograph should be pasted at the space provided on the admission form with two additional copies to be appended there with.
- (b) Self attested copies of Matriculation/Secondary/Senior Secondary School Certificate or a certificate of its equivalent public examination showing the candidate's date of birth.
- (c) Self attested copies of the certificates of having passed/ appearing in the qualification examination from the University/College/School/Institution last attended by the candidate.
- (d) Character certificate reporting on the inter personal/Social behavioural pattern of the applicant issued by the School/College/Institution last attended by the candidate.
- (e) Certificate of SC/ST/OBC/PWD/ESM for statistical information or for getting the benefit of relaxation in age or marks in the qualifying examination or for reservation of seat allotment.

Original Migration certificate from the Board/University last attended (to be submitted at the time of admission or within 15 days from the date of admission). Afterwards late fee will be applicable as per University/Board guidelines.

The candidate must mention his/her own and that of his/her Parents Phone/Mob. No. and email address at the space provided in the admission form. Any change in the contact number/ email address must be intimated to the Admission Office.





(h) The students claiming SC/ST/OBC/DISABILITY Scholarship under the relevant scheme of the Government should submit the Income Certificate and relevant documents to the applying scholarship scheme in the concerned institute within one month from the date of admission.

#### Documents to be brought at the time of Counselling and reporting to college

After submission of the Admission Form, the candidates are required to report for Counselling and Admission at the respective University on the date and time as indicated against each course in the chapter of Eligibility for admission in the Prospectus and bring with them the following original certificates for admission to the course concerned.

(Originals for reservation claim)

- (A) Original Matric Certificate for date of birth proof.
- (B) Original Intermediate certificate
- (C) Original Marks Sheet/Certificates of having passed the qualifying examination on the basis of which the candidate claim for admission.
- (D) Character certificate reporting on the inter personal/ social behavioural pattern of the applicant issued by the University/Board/School/Institution last attended by the applicant.
- (E) Original Migration certificate from the Board/University (To be submitted at the time of counselling or within 15 days from the date of admission).
- (F) Undertakings against ragging by students and their parents to be submitted at the time of Counselling.
- (G) One set of self attested copies of the relevant documents.

#### Other important instruction for admission

- Admissions forms which are incomplete or without copies of the requisite documents or received late, are liable to be rejected.
- b) All admissions are made provisional subject to their registration with the concerned University/Examining Body after completing requirement as per rules/ordinances of the respective Examining body.
- c) A candidate, who does not report for the counselling in person on the date of counselling as per schedule, shall forfeit his/her seat.
- d) The fee is to be deposited at the time of counselling and reporting to the respective concerned admitted college.
- e) If a student fails to attend the classes continuously for seven days from the date of commencement of the classes or from the date of admission, (in case admission has been made after the commencement of the classes), his/her admission shall be cancelled without any further notice.
- f) The candidates who have passed their examination from any unrecognised/fake university/Board are not eligible. In case it is revealed at any subsequent stage that any candidate has sought admission to any course of the University/Board on the basis of examination passed by him/her from any fake University/ Board, his/her admission shall be cancelled without any notice. The list of fake Universities /Board is available on the website of the UGC/AICTE.
- g) The admission form received late will not be considered. The University/Institute will in no way be responsible for delay or loss of admission form or correspondence pertaining thereto, in postal transit or through courier services.
- h) Candidate should specify the name of course(s) to which the admission sought in the envelope in which the admission form is sent.
- i) In case of refund of fee admissible under the rules, a deduction of fee will be made as under ::
- I. Within 15 days of admission: 1000/-
- II. After 15 days up to 30 days of admission : Proportionate amount of fee
- III. After 30days of admission : No refund offee.

# Regulation for curbing the Menace of Ragging

- Ragging is totally prohibited in the campus of Ambedkar Mahabir Group of Institution and anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to punished in the accordance with the regulation framed and notified by the UGC / HSBTE and other regulating council like NCTE/AICTE etc. as well as under the provisional of any penal law for the time being in force.
- Regulations for elimination of Ragging shall be applicable not only to the Institutions or any part thereof, including, but not limited to, the departments, colleges, centre of studies and all its premises, whether academic, playground, or canteen, whether located within the campus or outside, and all means of transportation of students, whether public or private, accessed by students for the pursuit of their studies in such institutions.
- Ragging constitutes one or more of any of the following acts.
  - Any conduct by the student or students whether by words spoken or written or by any act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
  - b) Including in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
  - c) Asking any student to do any act which such will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
  - Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
  - e) Any act of financial extortion of forcefully expenditure burden put on a fresher or any other student by students;
  - f) Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
  - g) Any act that affects the mental health and self confidence of a fresher or any other student- with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
  - Parent/ Guardians of the candidates for admission to any course in any of the Institutes of the Group shall submit the affidavit/ Undertaking at the time of reporting to the respective institute mentioned that if his/her child found/indulge in the ragging his/her candidature will be cancelled out with short notice or their child is ensure the institute not indulge in this matter.
  - While the Ambedkar Mahabir Group of Institutions assure to fully adhere to all the relevant Regulations on curbing the Menace of ragging and to take all necessary precautions to avoid any case of Ragging with any student of the Institutions.
  - No leniency will be shown to any student involved in rag ging. All the students are advised to note and co-operate in keeping our Institutions free from ragging.
